events and student activities occur at various times throughout the year including before school, during school and after school. Our School Advisory Council (SAC) and our Parent Teacher Organization (PTO) meets monthly or a total of ten times throughout the year. Per SAC guidelines, the meetings are held face to face with a virtual option for parents who are unable to attend in person. A translator is also provided if needed for the SAC/PTO meetings. We offer a school wide parent curriculum activity within the semester. The event is titled Pelican Palooza. The event brings together our EL Night, Art Show, STEM Night, Math Night, and ELA Night. In addition, community organizations are invited to share engaging, hands on activities that promote their mission. Title I funds contribute to these events. We offer a parent resource library that includes materials available for parent check out. Our Literacy Coach is available to assist parents with at home strategies and our teachers promote a positive school-to-home connection through conferences, websites and class activities.

Building the capacity of all school staff is important at Poinciana Elementary School. On a monthly basis, professional learning is provided to educate the teachers. Teachers are also encouraged to participate in professional learning outside our school. Rachel Spencer will provide training to POI Staff to share best practices to communicate and value parents/families. MCSD provides Professional Learning tailored to meet the needs of our Title I populations. At Poinciana, our AVID Site Team will collaborate and plan to enhance and support the relationship between students, staff, families, and community. Our SAC committee and PTO recruit and encourage involvement from families and community members.

Parent Resource Center

How other activities, such as the parent resource center, the school will conduct to encourage and support parents and families in more meaningful engagement in the education of their child(ren)?

Poinciana Elementary Schools hosts a Parent Resource Center within our main office. This room provides parents access to computers which have been used to complete lunch applications, check their child's grades and to pay their lunch or daycare bills online. We also maintain learning materials available for home use as well as brochures on a variety of topics. This center is maintained by our Title I representative and office staff. We encourage parental input with regards to helpful resources.

Our office staff, during the absence of a parent educator, assists students with learning materials which she provides to them and their families during Kindergarten Round-Up. It is our goal to find ways to promote a healthy and nurturing environment where all families feel welcomed in the school. Parents are invited to our school to utilize our library and Parent Resource Center for more resources. We offer a summer boost for our EL students. Specific learning materials are purchased from CHIPS that provide students with extended learning opportunities throughout the summer. These materials are available in Spanish, English and Haitian Creole.

In addition to our Parent Resource Center, Poinciana Elementary School uses various school resources to assist parents and families with their needs. Our school counselor, registrar and nurse provide guidance, food, and clothes to our students in need. In addition, they help parents get counseling services when needed through the Guidance Care Center, Key Bridge. Our media center offers extended hours so students can use the computers and enjoy a comfortable place to read or do homework before and after school. We have a partnership with Keys To Be the Change which provides a peer mentoring service to students.

Poinciana Elementary School will communicate with parents about the Title 1 programs during the September SAC meeting as well as an informational video that will be shared with parents and families through our school Facebook page. Parents will also be notified in advance when tutoring and other programs are available for academic enrichment and/or intervention support. Parents will be informed about the curriculum through Title 1 parent engagement nights that focus on ELA, Math and Science standards through activities and information. Poinciana Elementary recommends teachers reach out to all parents once in the first quarter. Teachers will notate on the progress report or grade card if a parent teacher conference is needed. Parents that are interested in a conference can call or email the teacher to schedule a time either before, during or after school face to face, virtual, or phone conference. All conferencing platforms will be acceptable to meet the needs of the parents, however, face-to-face conferences are recommended. Parents can email the Office Manager, submit their concerns through the Title 1 Survey or contact the school based Title 1 Contact, Sarah Garr.

POI utilizes the bilingual staff to assist parents throughout the year when needed.

Limited language proficiency in English and their home language of both parents and students.	We have bilingual staff onsite for Spanish and Haitian Creole families. They are available to attend parent-teacher conferences, EL Parent Involvement Events, attendance, 504 and IEP meetings as well as conduct home/wellness visits as needed.
Limited translation services for all languages spoken in homes.	We currently have 16 languages spoken at Poinciana. Our website offers translation services for families. Our district currently translates documents in both Spanish and Creole languages. We will continue to work with our Monroe County School District Communication Coordinator on ways to use print or audio/visual materials to communicate with all families regardless of their home language. In addition, our bilingual staff is available, when needed, to make Connect-Ed phone calls to translate pertinent information for our Spanish and Haitian Creole families. In addition, the district Blackboard Connect service provides translation for digital communication in 10 languages. The district also contracts a language line translation service that can be used by all staff on campus.
Work schedule and family obligation	Hold events at different times of day to allow more participation.
Time to provide EL & SWD services	Professional staff development in these areas as well as streamlining our master schedule to meet students' individual needs. This is not limited to ESE and EL students. We strive to find ways to engage parents in their child's education. This year we will have an MFLC counselor and VPK/Headstart Social Worker available to assist families.
Parents' inability to assist students academically.	In order to level the playing field for all students we revised our homework policy to include 30 minutes of nightly reading. Parents are able to request extension opportunities that are tailored for their child. In addition, free Title I tutoring is available afterschool. Lastly, a VPK/Headstart Social Worker available to assist families.
