#### Q&A No. 2

Q1 - Is the School Board of Monroe County looking for our team to serve as PM on the job or just have visits during construction? What level of involvement during construction is required?

A1 – The RFQ is for professional services as it relates to overall design, bidding and construction monitoring. The CM will be the Project Manager and the design firm will work closely with them throughout the project. Design firms are expected to have full participation from the start while reporting to the District under a separate contract apart from the CM.

Q2Is the School Board intending to utilize what is now the athletic field for the new school? If demolition of existing buildings is after new buildings are finished, that seems to be the choice, but wish to confirm.

# A2 – These decisions will be made once the Architectural firm is on board and we start the overall design process. The CM and Design teams will work together with the District to come up with the best options to be presented to the School Principal and School Board for approval.

Q3 - It is our assumption that security will be emphasized during this project. Is the School Board planning for modifications to existing school entrances? To enhance security, entrances should be controlled.

#### A3 – A single point of entry for the school will be emphasized during project design.

Q4 - Will the new school contain only classrooms? Or will they also contain support spaces such as Cafeteria, Media Center, Offices, etc.?
