Title: Technician Assistant Instructional Technology

GENERAL DESCRIPTION

This is technical work involving the installation, setup, operation and maintenance of computers, computerized equipment, peripheral equipment and software within a school or district office. This position works within a larger infrastructure in support of Network Specialist and System Administrator.

Primary Duties:

Installs, troubleshoot and performs maintenance and preventive maintenance of computer equipment, peripherals and software using various software utilities and tools.

Relocates equipment and software as needed.

Ensures equipment and software are current with patches and updates are installed properly.

Installs and maintains site-appropriate licensed instructional software.

Provides technical assistance and advice to users of computer equipment and software.

Logs work orders in help desk software for time tracking and resolution.

Learn fundamental operations of commonly used software, hardware and other equipment.

Keeps maintenance, warranty, operation documentation and inventory records.

Attends training, seminars and conferences as necessary to maintain and enhance job knowledge and skills.

Prepares various records and reports as required by individual schools, the District and/or other agencies.

Performs routine administrative/office tasks as required, including but not limited to processing work orders, preparing reports and correspondence, copying and filing documents, answering the telephone, sending and receiving faxes, entering and retrieving computer data.

Performs related work, as required and/or assigned.

GENERAL RESPONSIBILITIES AND REQUIREMENTS

Data Responsibility:

"Data Responsibility" refers to information, knowledge, and conceptions obtained by observation, investigation, interpretation, visualization, and mental creation. Data are intangible and include

numbers, words, symbols, ideas, concepts, and oral verbalizations.

Coordinates or determines time, place, or sequence of operations or activities based on analysis of data and possibly executes determinations or reports on events.

People Responsibility:

"People Responsibility" refers to individuals who have contact with or are influenced by the position.

Provides assistance to people in achieving task completion; may instruct and supervise assistants as assigned.

Assets Responsibility:

"Assets Responsibility" refers to the responsibility for achieving economies or preventing loss within the organization.

Requires responsibility and opportunity for achieving moderate economies and/or preventing moderate losses through the management or handling of supplies of high value or moderate amounts of money.

Mathematical Requirement:

"Mathematics" deals with quantities, magnitudes, and forms and their relationships and attributes by the use of numbers and symbols.

Uses basic algebra calculating variables and formulas, and/or basic geometry, calculating plane and solid figures; may compute discounts, interest, ratios and proportions, and percentages.

Communications Requirements:

"Communications" involves the ability to read, write, and speak.

Reads technical instructions, charts, and/or procedures manuals; composes routine reports and completes job forms; speaks compound sentences using standard grammar.

Complexity of Work:

"Complexity of Work" addresses the analysis, initiative, ingenuity, creativity, and concentration required by the position and the presence of any unusual pressures.

Performs coordinating work involving guidelines and rules with constant problem solving; requires continuous, close attention for accurate results or frequent exposure to unusual pressure.

Impact of Decisions:

"Impact of Decisions" refers to consequences such as damage to property, loss of data or property, exposure of the organization to legal liability, or injury or death to individuals.

Makes decisions with moderate impact - affects those in work unit.

Equipment Usage:

"Equipment Usage" refers to inanimate objects such as substances, materials, machines, tools, equipment, work aids, or products. A thing is tangible and has shape, form, and other physical characteristics.

Coordinates the handling of machines, tools, equipment, or work aids involving extensive latitude for judgment regarding attainment of standard or in selecting appropriate items.

Safety of Others:

"Safety of Others" refers to responsibility for other people's safety, either inherent in the job or to assure the safety of the general public.

Requires some responsibility for safety and health of others and/or for occasional enforcement of the standards of public safety or health.

Education Requirements:

"Education Requirements" refers to job specific training and education required for entry into the position.

One year of college or vocational school education in computer technology, information systems management or a related field preferred.

Licenses Certifications Registrations Required:

"Licenses, Certifications, and Registrations" refers to professional, state, or federal licenses, certifications, or registrations required to enter the position.

Requires a valid state driver's license.

May require specific technical certifications as deemed necessary by supervisor.

Experience Requirements:

"Experience Requirements" refers to the amount of work experience that is required for entry into the position that would result in reasonable expectation that the person can perform the tasks required by the position.

Experience in Instructional Technology is preferred.

Physical Demands:

"Physical Demands" refers to the requirements for physical exertion and coordination of limb and body movement.
