4. Teachers Salaries And Affordable Housing

A balancing needs to occur with teachers salaries in relation to affordable housing. Paula Wittke raised the issue of inadvertently raising the teachers tax brackets with higher salaries while the cost of affordable housing is extremely high. Maybe offer a housing allowance in lieu of a higher salary to possibly offset?

 F.A.S.T (Florida Assessment Of Student Thinking) Jacob Poelma September is a very heavy month for testing and Florida is the 1st state to institute progress monitoring testing known as FAST. These tests are administered several times a year, beginning, middle and end of year and are able to identify students' progress more accurately but it is still in the beta testing so the Upper Classmen will not have the advantage of seeing their full progress measured as accurately as all other classmen.

6. College And Career Counselor Laura Lietaert

A college and career counselor is set to start on 10/4 but for the time being, both of the guidance counselors are available during the lunch hours to speak to the students with any concerns they may have
