GUIDANCE

CARE CENTER Amy Beeler

Minutes from last meeting (September) moved by Talley Anne Reeb and seconded by Dana Portillo for approval.

MCSD UPDATE:

1. None at this time.

FDOH-MONROE UPDATE:

1. Narcan distribution program started at DOH after education protocols put in place.
2. Discussed Narcan supply for our schools and how fortunate we are to have community relationships. School Narcan supply provided by partnership of Guidance Care Center and Monroe County Coalition.
3. Immunizations- school nurses are working to get permission slips from parents of 6th graders to do vaccine pods by Dana Portillo from Marathon down. Clarice Strang, RN, is managing these outreaches in upper keys schools.
4. FLU pods done for school staff and local outreach.
5. Alison Kerr mentioned that flyers were received for insurance open enrollment and asked for guidance for distribution to schools. Ashley Ravelo asked for some at HOB and she will distribute. Dana Portillo recommended an email for DOE review before distributing in schools. Email was forwarded to Amber Acevedo for approval.

AHEC:

1. School Based Dental Sealant Program (SBDSP)(for 2nd and 7th grade) already done in two schools. One more visit this Friday at Stanley Switlik and all others will be done after the Christmas holiday. Referrals will continue to be done for the dental bus.
2. The Dental bus is booked through April/May. They are taking names in case of cancellations/no-shows to try to accommodate all needs.

3. Dental bus added additional days to work with Head start students. Dental supplies were provided to families to encourage dental hygiene at home. Panoramic xrays will be done in Marathon for students able to come there. They will also be at Gerald Adams December 19th and 20th to accommodate extra dental needs.
4. All health centers are fully staffed. Provider in Poinciana was switched and now we have Steve Stillman? (formerly at Urgent Care). Jessica Henry is in the middle keys. Pam McGarvey was going to retire but will remain a couple days a week in Sugarloaf. All clinics open through the 16th, off for school Christmas break, and will reopen January 3rd.

HEADSTART UPDATES:

1. Dental Screening 90 day deadline is now complete. AHEC has been an essential partner (and will continue to be) and she is grateful. The students did great.
2. Daily teeth brushing was cancelled for this group during COVID. Ashley and her team will reinstate this daily event for her students when they return in January.

HEALTH DEPARTMENT- SMOKING CESSATION UPDATES:

1. Kimberly Stevens is the new smoking cessation representative at DOH-Monroe. She recently met with Talley Anne Reeb, Dana Portillo, and Alison Kerr to discuss options/resources moving forward.
2. Kimberly presented a slideshow of the purpose- strategies for policies to deal with enforcement of policies rather than punishing/suspending students. This program is intended for 1st and 2nd offenses. There is a program available for students at administrator's referral. There are also free courses available for teachers and nurses, with education credit available.
3. At this point, no one from DOE has been contacted about implementing this as a potential policy as opposed to options available for best practice. This should happen over the next month or so.
4. Michael Cunningham mentioned that Tobacco Free Florida (another part of his AHEC team) has materials waiting at the district to be offered/implemented. Students and staff can be referred for assistance with quitting. The difference between teen and adult programs is that adults will be offered nicotine products to help with cessation, and those under aged 18 will not.
