30 DAY IMMUNIZATION EXEMPTION

August 2023

Dear Parent or Guardian,

Florida Statute 1003.22 requires each child who is entitled to admittance to Kindergarten, or any other initial entrance into Florida public schools, to present a certificate of immunization for the prevention of those communicable diseases for which immunization is required. Additionally, the Department of Health and Rehabilitative Services require a school-entry health examination, performed within one year prior to enrollment in school.

The statute further requires these documents be completed prior to enrollment, and prohibits a school from admitting a student, regardless of grade level, who does not comply with the law. Further, the statute makes parents or guardians of school children responsible for compliance with the law.

The law does provide for a school to issue a temporary 30-day exemption for a student transferring from another state or country in order to allow time for the transfer of records.

Through a copy of this letter signed and dated by your school principal, you are hereby granted a temporary 30-day exemption as provided by law. However, by your signature on a copy of this letter you are acknowledging that your child will be excused from further attendance after the date indicated if the proper records of certification are not on file at the school.

Exención Temporal de 30 Días

Estimado padre o Guardianes,

El Estatuto de Florida 1003.22 requiere que cada niño que tenga derecho a ser admitido al jardín de infantes, o cualquier otro ingreso inicial a las escuelas públicas de Florida, presente un certificado de inmunización para la prevención de las enfermedades transmisibles para las que se requiere inmunización. Además, el Departamento de Salud y Servicios de Rehabilitación requiere un examen de salud de ingreso a la escuela, realizado dentro de un año antes de la inscripción en la escuela.

Además, el estatuto requiere que estos documentos se completen antes de la inscripción y prohíbe que una escuela admita a un estudiante, independientemente del nivel de grado, que no cumpla con la ley. Además, el estatuto responsabiliza a los padres o tutores de los niños en edad escolar del cumplimiento de la ley.

La ley prevé que una escuela emita una exención temporal de 30 días para un estudiante que se transfiera de otro estado o país a fin de dar tiempo para la transferencia de registros.

Mediante una copia de esta carta firmada y fechada por el director de su escuela, por la presente se le otorga una exención temporal de 30 días según lo dispuesto por la ley. Sin embargo, con su firma en una copia de esta carta, usted reconoce que su hijo será excusado de seguir asistiendo después de la fecha indicada si los registros correspondientes de certificación no están archivados en la escuela.
