

# Panther Procedure Compact

Monroe County is implementing a district wide behavior plan called iBELIEVE! This plan will provide the teachers, students, administrators, and families with a common language when discussing expected school wide behavior and expectations. Please take some time to discuss with your students and teachers to begin the talk of expectations for all.

To aid in the discussion, listed below are several of the school wide Panther procedures that affect all students, teachers and family members involved. Please take the time to review these expectations with the students so that the procedures remain consistent and enforced throughout the year.

## **Dress Code:**

While students are permitted wide latitude in their choice of attire, **school teachers and officials will act as the judge of the appropriateness of clothing**. If students are in violation of the dress code, they will be required to call home so appropriate clothing can be delivered to school. Students will receive counseling and possible detention when they are out of dress code. Repeat violations will result in further disciplinary action.

### Dress for success:

- . Shorts, skorts, skirts and dresses should be mid-thigh or shorts must be walking/Bermuda length (no holes, rips or frays)
- . Polo OR Non-Collard shirt with sleeves. (appropriately worn & size appropriate NO bare shoulders, cut-outs, holes or deep neckline)
- . Denim jeans, Khaki pants or slacks (no holes, rips or frays)
- . Any transition/hybrid, cargo, Bermuda (walking) style shorts

### Dress Code Violations:

- . Miniskirts, bathing suits, or tube tops are not acceptable.
- . Leggings or jeggings
- . Athletic-type basketball shorts or athletic spandex
- . Clothing items which are offensive, suggestive, contain profanity or references to drugs, alcohol and sex are not appropriate.
- . Sweat or pajama pants
- . Heels in excess of 1 inch.
- . Slide shoes

## **Recess Expectations:**

Attire must be appropriate for the activity (no flip-flops in soccer, no cleats, etc.)

Balls and equipment should be used according to their non-contact sport.

Any natural features on the play area should be off limits for play (trees, sticks, rocks, etc.).

Students will remain in designated area.

## **Cafeteria Expectations:**

Choose a seat and stay seated

Carry on QUIET and APPROPRIATE conversations

Use good manners

Clean up area

Raise your hand for assistance

## **Bus Expectations:**

NO BUS CHANGES (Students must ride designated bus only) NO ONE DAY PASSES

Remain seated at all times while on bus

Use quiet voices

Listen to instruction from the bus driver

## **Drop off and Pick up Procedures:**

No student shall be released after 2:00 pm of the school day.

No dismissal changes after 2:00pm

Drop off and pick up are only permitted in designated areas to ensure the safety of all students, parents and staff.

Changes to routines must be submitted to the teacher in writing AND through office contact by the parent.

Students are not permitted to leave the sidewalk/designated area unless accompanied by an adult.
