4. Title 1/Food Program Benefits

6. Sporting Events

- a. Everyone that wants to attend will have to purchase tickets on RevTrack. The KLS website will have a button to purchase event tickets. 7. Phone Policy

- a. Students are to have their phones put away in their bags and turned off before they enter the campus to begin their school day.
 - b. NO PHONES are to be out during passing from class to class.
 - c. Students are NOT allowed to have their phones during lunch.
 - d. Students are to keep their cell phones turned off and in their backpacks for the entire day.
 - e. Cell phones are allowed once students step off campus.
 - f. Cell Phone use will be allowed for after school activities and sports only.
 - g. Parents/Guardians are advised that the best way to get in touch with their child during the school day is by calling the school office, at 305.453.1255
 - h. If a cell phone rings, vibrates, is used for any reason, or is visible anytime during class time, or if you are caught using it on campus during any time, a staff member may confiscate the device.
 - i. Students are allowed to wear smart watches
- Earbuds/Earphones**
- a. NO earbuds/earphones are allowed on campus. Earbuds/earphones seen will be collected, put in an envelope with the student's name, and turned into administration.

- b. It should be noted that neither the school nor its employees are responsible for the loss or damage to any student's phone or electronic device.
 - c. It is the responsibility of the student to adhere to this policy and to secure their belongings at all times.
 - d. Classes and or instruction will not be stopped to deal with or search for lost phones/devices.
