For renewal of all subjects and endorsements on your FL professional educator certificate, 120 points are required within the validity dates of your current certificate. The FLDOE specifies that a portion of the professional learning meets certain standards.

SWD

Twenty (20) of those 120 points must be in methods of teaching students with disabilities "SWD." **This requirement applies to everyone.**

READ

Forty (40) of those 120 points must be in "in the use of explicit, systematic, and sequential approaches to reading instruction, developing phonemic awareness, and implementing multisensory intervention strategies." This requirement applies to anyone with the following coverages on their certificate (regardless of job title):

- Elementary Education (K-6)
- Prekindergarten/Primary Education (age 3 through grade 3)
- Elementary Education (grades 1-6)
- Primary Education (grades K-3)
- English (grades 1-6)
- Middle Grades English (grades 5-9)
- Middle Grades Integrated Curriculum (grades 5-9)
- English (6-12)
- Reading (K-12)
- Reading (Endorsement)
- English for Speakers of Other Languages (ESOL K-12)
- Exceptional Student Education (K-12)

EdL

Twenty (20) of those 120 points must be in Florida's educational leadership standards. This requirement applies to anyone with the following coverages on their certificate (regardless of job title):

- Educational Leadership (all grade levels)
- School Principal (all grade levels)
